	WHEREAS on October 6, 2011, two children under the age of three left Day Nursery Centre Inc. – Gretta Brown (the Centre) unescorted by any staff and attempted to cross a street without an accompanying adult before a third party witness stopped them and returned the children back to the Centre. In addition to allowing children to remain unsupervised outside the Centre, it was reported that when the children were returned to the Centre, staff were not aware of their absence.	
	AND WHEREAS on or about October 6, 2011, staff of the Centre were not able to immediately provide the area child care coordinator the accurate total number of children in their care and present in the Centre playground.	
	AND WHEREAS the foregoing violates <i>The Community Child Care Standards Act</i> ("the Act") section 3(1), which states:	
	3(1) Every person providing child care shall at all times provide an environment that is conducive to the health, safety and well-being of the children.

	8(1) Every licensee shall ensure that children attending the child care centre are supervised at all times.

8(1.1)	 (2) A written plan must be submitted to the area child care coordinator and approved by the Director describing: (a) how children will be supervised during outdoor play and on any outings/field trips away from the Centre; (b) how staff will ensure children are accounted for during outdoor play and on any outings/field trips away from the Centre; (c) how staff monitor the entrance(s) into the Centre from the outdoor playground; and (d) how children will be transitioned to and from outdoor play and how children are accounted for at all such times. 8(1)	(3) No outings/field trips away from the Centre may be conducted until the above-noted written plan has been submitted to the area child care coordinator and approved by the Director.	IMMEDIATELY
8(1.1)	(4) Until further notice, transition to and from outdoor play in the adjacent and enclosed Centre playground, must only occur with small groups of children (no more than the allowable number of children outlined in the Regulation pertaining to staff to child ratios).	IMMEDIATELY

	(7) All centre staff must attend a workshop related to child care legislation with respect to supervision and attendance records, to be arranged and conducted by the area child care co-ordinator.	November 14, 2011
	(8) All parents with children currently enrolled in the Centre must be informed, by the Licensee, of this Order.	IMMEDIATELY
	This Order must remain in a prominent place within the Centre at all times and is not to be removed until authorized by the Director of Manitoba Early Learning and Child Care.
