Regulation Number	WHEREAS on May 17, 2023, it has been reported to Early Learning and Child Care Division that an incident occurred on May 17, 2023 at St. Amant Inc. operating as River Road Child Care (the "Centre"), whereby a 2 year old child was alone in one of the classrooms within the Centre, unsupervised by Centre staff for approximately 2-3 minutes.  As reported by the Centre Supervisor, Room One had 19 children in attendance, a group of 8 children with one staff were outside and two groups (11 children with 2 staff) were inside at 13:21 when the fire alarms rang during nap time. One staff supervising 5 awake children escorted the group to the exit door and when code red was called, took those 5 children outside to the gathering area. A second staff supervising 6 children in the sunroom, 4 of whom were napping, gathered 5 of the children when the alarms rang and escorted them to the exit door and when directed, proceeded outside to the gathering area under the canopy. A third staff who was on their break came and did a final sweep of the area before joining the group outside. Once all three groups were together, a headcount and attendance (name-face recognition) was conducted and the staff discovered one child was not present. 	On April 26, 2023, it was reported to Early Learning and Child Care Division that at approximately 14:50 a 3 year old child was left unsupervised for 1 - 2 minutes when a group of 6 children with one staff were transitioning from the centre hallway to Room 2. The child was returned to the group by another staff who noticed the child alone in the hallway.	
	On April 24, 2023, it was reported to Early Learning and Child Care Division that at approximately 10:10 a 3 year old child was left unsupervised in the washroom for 5 -10 minutes when a group of 7 children with one staff were transitioning from the hallway to the outdoor play space. The child was found by another staff who heard a noise and then discovered the child sitting on a stool at the entrance to the bathroom.
