	WHEREAS it has been reported to Early Learning and Child Care Division that on May 19, 2023 an incident occurred at Centre D'Enfants Saint Claude Children's Centre Inc.(the "Centre"), whereby a 3 year old child left the fenced facility playground, unsupervised by Centre staff.	
	As reported by the Centre's Assistant Director, 5 preschool children and one staff, were outside in the playground. At approximately 14:00 the staff did a scan of the playground and did not see one of the children. The staff proceeded to look for the child in the playground and saw the child outside of the fenced area. The staff called for another staff from inside the Centre, to come out to the playground to assist. The staff then left the fenced area to bring the child back. The child was located on Provincial Road 240, approximately 70 metres (229 feet) away from the centre. The child was unsupervised by Centre staff for a period of approximately 3-5 minutes.	
	A subsequent incident was reported to Early Learning and Child Care Division which occurred on May 24, 2023 at Centre D'Enfants Saint Claude Children's Centre Inc., whereby a 2 year old child left the preschool outdoor fenced area and entered into the adjacent infant outdoor fenced area and was unsupervised by Centre staff. 	As reported by the Centre Director, 17 preschool children and 7 infants with 5 staff were in the preschool outdoor fenced area. At approximately 16:45 a staff took 3 children through the fenced infant area and inside the centre for diapering. A 2 year old child was standing near the gate. The staff instructed the child to stay outside and informed the rest of the Centre staff that 3 children were being taken inside. Approximately 5-10 minutes later, another staff did a visual scan which included a face to name attendance check and realized one child was missing. Centre staff proceeded to look for the child and as the staff was approaching the gate to the infant area, a parent who had just arrived, informed them that there was a child alone in the infant fenced area. The child was unsupervised by staff for a period of approximately 5-10 minutes. Department staff conducted an unscheduled inspection on May 25, 2023 and documented safety concerns with regards to the height of the fence, spaces in the fence where temporary fencing is in place and a gap under the gate between the infant and preschool areas.
