	<p>WHEREAS it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on January 15, 2013, while on a field trip to Centennial Pool, Day Nursery Centre Inc.– Gretta Brown staff left a 4 year old child unattended in the ladies' change room for 1-3 minutes.</p> <p>As reported to MELCC, eleven children and three Centre staff attended the pool for the "Grandparenting Swim Program". Upon arrival at the pool, Centre staff assisted children to prepare for the swim session. Children were taken to the pool area in separate groups as they were late for their swimming lesson. The first Centre staff escorted six pre-school children to the pool area, followed by a second centre staff with three pre-school children, at which time each child was partnered with a grandparent. The two Centre staff then took a seat alongside the pool to supervise.</p> <p>The third Centre staff remained in the dressing room to assist a child in the washroom. It was reported she was unaware she had two children in her care. As a result, she escorted only one child to the pool area therefore leaving one child in the change room unattended.</p> <p>It was then reported that at approximately 10:03 a.m., a pool life guard brought a child out of the change room to the pool area. As the child was wearing a white bathing cap, Centre staff recognized him as a child from their Centre.</p>	






