Daily incidentsshould be recorded and shared with parents daily. Section 17 states that: Every licensee shall ensure that: (e) emergency evacuation procedures are practiced at least once a month for all children in attendance at the licensee's child care centre, and written records are kept indicating the date and time of each drill and the number of staff and children evacuated and are maintained on file for a period of 1 year. Under the guideline it states: "Plans for evacuating children should also include when children are asleep, as well as different times of the day."
