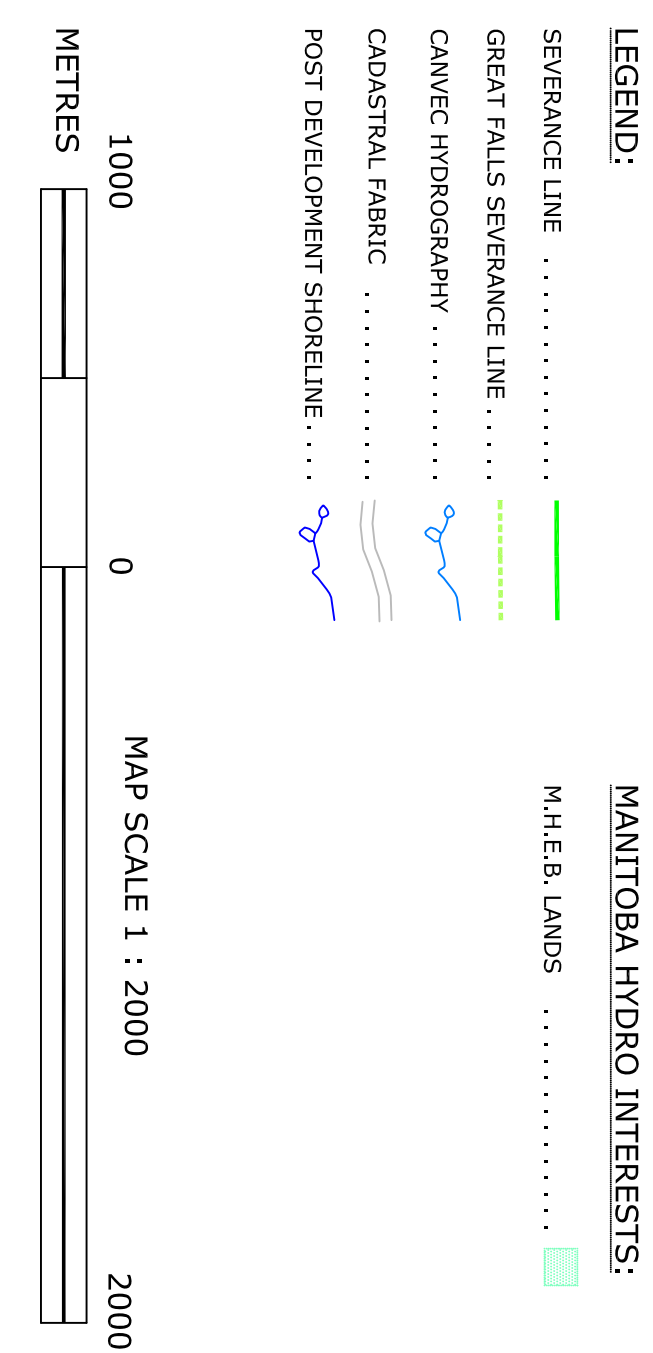
3. THE MAP PAGE FOR THE DRAWING IS A COMBINATION OF:
